SPECIAL DEPONMATION BULLETIN

Student

In an effort to communicate more fully with prospective students, the faculty and Administration have amplified the student pledge that new students are asked to sign upon application to the College. It is hoped that this affirmation will more clearly communicate the expectations that the College has for the student in that it satisfactorily outlines the reasons for these expectations. The affirmation will become effective with the Spring Quarter.. It is as follows:

AFFIRMATION

As an academic institution, Northwest College has among its distinctive purposes for existence the stimulation and guidance of young people to a broadened spiritual and social awareness. The College considers that concern for and involvement in the spiritual and social welfare of its students are integral parts of its reason for being. In keeping with this concern, the College has sought to evaluate certain matters of conduct and has developed a code of student citizenship. It has concluded that such things as the use of alcoholic beverages, tobacco, or illegal drugs, the attendance at public theaters,¹ dancing, or the reading of prurient or pornographic literature do not serve best spiritual and social interests of the students. Such behavior disturbs and often destroys the spiritual and social educative processes the College seeks to conduct.

In applying for admission to Northwest College, I affirm that I am in agreement with the stated purposes of the College and will conduct myself in keeping with the standard of citizenship. I fully understand that the College has the right to terminate the enrollment of anystudent who by his own action disrupts any means the College establishes to attain its objectives.

¹The term "public theater" in this statement means the movie theater or drive-in theater where Hollywood-type films are shown. Exceptions to this standard may be made by the Administration for religious or scientific films, or films that are educational in production and content. While the term "public theater" does not refer to attendance at opera or live-stage productions, it is recognized that the principles of selectivity and Christian testimony must be exercised in these areas.

SPECIAL NOTICE

In keeping with past policy regarding religious films, the College Administration has made exceptions to the theater prohibition statement for the films "Two for a Penny" and the "Dave Vilkerson Story" so that students may attend. It is hoped that a number will volunteer to be counselors for "Two for a Penny."

The Counseling Committee for "Two for a Penny" have requested Northwest College students to assist in counseling. A meeting of counselors for the Seattle showings which will be March 24-30 will be held on Monday, March 8 at 7:00 p.m. at the Denny Park Luthern Church, 766 John Street, in Seattle. There will be only one training session to prepare counselors for the 20 Seattle showings. Students interested should sign on the list at the Receptionist's desk in the Administration Building.
