a week long missions convention) in the Full Gospel Central Church, the world's largest with 700,000 members; to Bangkok, where he ministered in the Central Church and the Bible School for which he broke ground three years earlier; to Rangoon, Myanmar (Burma) where he spoke in burgeoning Central assembly of that city and the Bible School, eastern Europe including Austria, Hungary, Yugoslavia and the Soviet Union, to Singapore many times where he preaches and consults with the 4,000 constituents Calvary Charismatic Centre and to the Philippines where he consults with the Asia Pacific Bible Schools Regional Office.

#### **Current Ministries and Immediate Past**

Dr. Hurst, currently is the President of the Asia Theological Centre For Evangelism and Missions (ATCEM). He makes five trips to Singapore each year to give guidance to the school, schedule classes and engage faculty. One of the distinguishing factor of the school is the many foreign (mostly Americans) professors and pastors brought to it for two weeks block lectureship - usually ten to twelve each year. Dr. Hurst also is currently engaged as Consultant to the Asia Pacific Education Office of the Assemblies of God and to the Calvary Charismatic Centre of Singapore. He served as Chairman of the Capital Campaign for the Assemblies of God Theological Seminary, Springfield, MO; a campaign which raised six million dollars to erect permanent facilities and endow scholarships. He is a member of the Accreditation Commission of the Asia Pacific Theological Association. He also conducts seminars for Boards of Deacons and ministers in camps, councils, missions conventions and conferences.
